The Shri Bhausaheb Muluk Charitable Trust, has applied for establishment of Bhausaheb Muluk **Ayurved College** at Plot No. 73, and OSP 73, R & C Zone, M.I.D.C. Butibori, Tal. Hingana Dist, Nagpur 441122. On careful consideration of the proposal, the Government of Maharashtra has decided to issue No Objection Certificate to the applicant for the establishment of an Ayurved college with 100 (**Hundred**) seats.

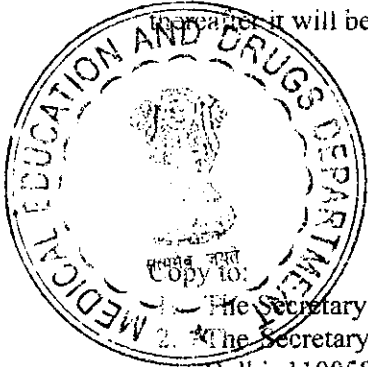
It is certified that :-

- The applicant owns & manages 100 Bedded Hospital which was established in 2015.
- It is desirable to establish an Ayurved college in the public interest for starting BAMS course and
- Establishment of Bhausaheb Muluk **Ayurved College** with 100 admission capacity for BAMS course at at Plot No. 73, and OSP 73, R & C Zone, M.I.D.C. Butibori, Tal. Hingana Dist, Nagpur 441122 by Shri Bhausaheb Muluk Charitable Trust is feasible.

It is also certified that adequate clinical material as per norms of the Central Council of Indian Medicine is available with the proposed Ayurved College. It is further certified that in case the applicant fails to create infrastructure for the Ayurved college as per Central Council of Indian Medicine norms and fresh admissions are stopped by the Central Government, the State Government shall take over the responsibility of the students already admitted in the college with the permission of the Central Government.

This Certificate is Valid for a period of 3 (three) years from the date of issue i.e..28.4.2016
